

Summary

- After April's record performance, U.S. equities continued to rally in May, as markets
 anticipated relief from a COVID-19-driven economic slowdown. The S&P 500° gained
 5%, and mid-caps performed even better, with the S&P MidCap 400° up 7%. While
 still relatively high, volatility calmed, with the VIX° closing the month at 27.5.
- International markets also posted gains, with the S&P Developed Ex-U.S. BMI and S&P Emerging BMI up 5% and 1%, respectively.
- All factors and sectors posted gains, with High Beta and Momentum in the lead. Info
 Tech was the top performing sector.
- U.S. fixed income performance was mostly positive, with the biggest gains in leveraged loans and munis.
- All commodities except for Agriculture rallied, with Energy in the lead.
