
### Summary

- U.S. equities gained steam in April, powered by positive earnings, potential progress in U.S./China trade talks, and recent dovish sentiment from the Fed. The S&P 500<sup>®</sup>, the S&P MidCap 400<sup>®</sup> and S&P SmallCap 600<sup>®</sup> all gained 4%, and the VIX<sup>®</sup> declined to 13.12.
- All U.S. equity factors rose in April, with High Beta and Enhanced Value taking the lead. Across sectors, Financials and Communication Services were the top performers, up 9% and 7%, respectively, while Health Care was the laggard.
- International markets also posted gains, with the S&P Developed Ex-U.S. and the S&P Emerging BMI up 3% and 2%, respectively.
- Fixed income performance was mixed, with leveraged loans outperforming and Treasuries lagging, as yields began to tick up.
- The S&P GSCI Energy gained 6% as oil continued its ascent, aided by U.S. plans to tighten sanctions on Iran and political turmoil in Venezuela.
