
- Despite a sharp drop on the final trading day of the month post Fed Chair Powell's comments indicating rate cuts were not imminent, the S&P 500® rose 2% in January. The month was characterized by a series of record highs, driven by strength from the Magnificent 7, which propelled the mega-cap S&P 500 Top 50 up 3%.
- Strong Q4 2023 economic growth also dampened optimism that the Fed would be able to begin cutting rates as soon as March, reflected in the underperformance of smaller caps, with the S&P SmallCap 600® down 4%.
- International equities declined, with the S&P Developed Ex-U.S. BMI and S&P Emerging BMI down 1% and 3%, respectively.
- Communication Services and Information Technology led sectoral performances while Materials and Real Estate lagged.
- Momentum led among our reported factor indices, up 6%, while High Beta suffered.
- Interest rate volatility led to mixed results among fixed income indices.
- Commodities performance was mixed: Livestock and Energy led, while Agriculture, Precious Metals, and Industrial Metals weakened.
